WORDS FROM THE CHAIRMAN



Despite the fact that we seem more connected than ever, it doesn't always feel that way when it comes to issues in our borough. For instance, Milltown residents were shocked to learn that the borough received reports of excess lead measurements in three borough test sites six months before a public information meeting was called to inform residents of simple, low-to-no cost actions they could take to lessen the impact of lead contamination in their water. This issue is just one example of why the Milltown Democratic Organization (MDO) felt it was important to start this newsletter.

PRESSING ISSUE

Borough residents and businesses are encouraged to flush their pipes before drinking or cooking. Six months after three test sites in the borough exceeded the allowable lead levels, councilwoman Doriann Kerber shared information about water quality and populations vulnerable to excessive lead in drinking water. MDO thinks this announcement took too long! Young children, pregnant women, and adults with pre-existing heart or kidney issues are more susceptible to lead contamination than otherwise healthy adults. Run your water for about 60 seconds before using it for drinking or cooking. Only drink or cook from the cold tap – hot water draws more lead from pipes and fixtures than does cold water. People can be tested for lead poisoning and household water can be tested for lead contamination.

MUNICIPAL GOVERNMENT 101 WHAT IS BONDING?

We frequently hear that certain municipal projects are being “bonded for.” But what exactly is bonding? A bond is a debt obligation issued by a local government. It is generally used to finance public projects like roads, schools, and infrastructure-related repairs within a municipality. Often bonding is the best way to complete a large-scale project in a timely manner. Repayment of this debt involves the full principal (amount borrowed), plus interest. So, other times bonding can be viewed as unnecessary and expensive, a poor alternative to planning and budgeting wisely.

The current project in Milltown being bonded for is a municipal complex that will house the public works garage, offices, a salt dome, and a new fire house. This is estimated to be a \$10 million project. Each resident will contribute to the repayment via their tax dollars and utility bills. MDO encourages judicious use of bonding to avoid hefty tax and utility rate increases.

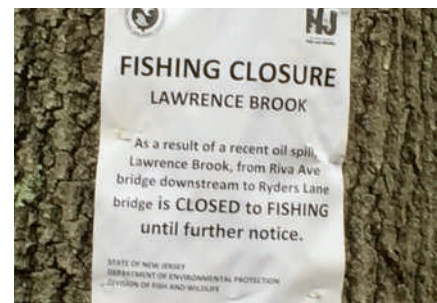

We bring this to your attention because fishermen have been seen casting their lines over the Main Street bridge. 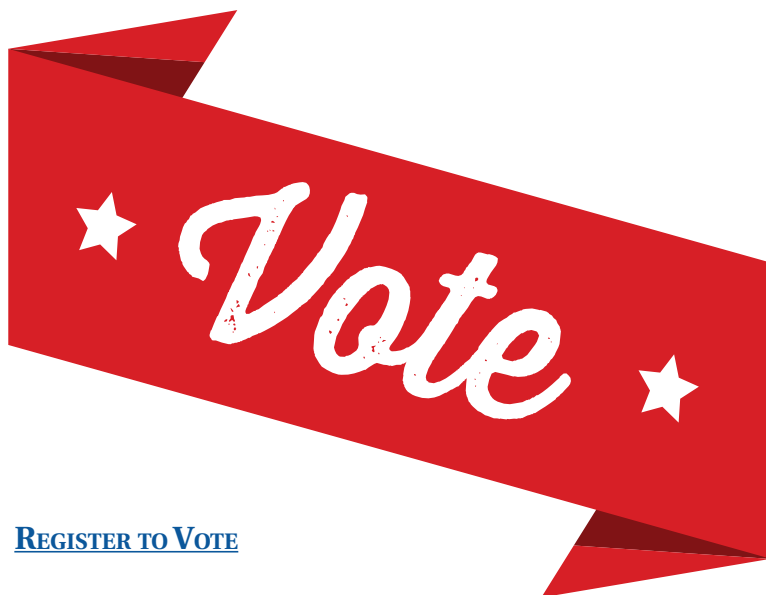


ATTEND THE NEXT MDO MEETING

REGISTER TO VOTE

Get yourself heard and make sure you are registered to vote in the upcoming elections. This year voters are going to shape the future for many generations to come. To be eligible to vote in any NJ state or county primary you must be affiliated with your party of interest.

On our website you can download and print:

- Vote By Mail Application
- Party Affiliation Declaration Form
- Voter Registration Form

Who May Register to Vote in New Jersey:

A native-born or naturalized U.S. citizen who is:

- 18 years old by election day
- A resident of the state and county at least 30 days before an election
- Not denied right to vote due to either court adjudication of “idiocy” or “insanity”
- Not serving a sentence, or on parole or probation for an indictable offense

One must be registered to vote at least 21 days before the next election. Deadline for the next primary election is May 16, 2017. Deadline for the next general election is October 17, 2017.

When to Re-Register in New Jersey:

Registration is permanent but you must re-register if you:

- Change your name: You are entitled to vote only in the next election by signing your registration sheet at the polls with both your previous and new name. After that, you must re-register in your new name.
- Change your residence within the county: By the 21st day before election, file a change of address form go to www.njvoterinfo.org for more information.
- After the 21st day before election, you may correct your registration on election day at the office of the municipal clerk in your new community of residence.
- Change your residence outside county: By the 21st day before election, you must re-register in new county. If you move after the 21st day before an election, you are permitted to vote in your former election district after signing an “Affirmation of Residency” form.

ABOUT MILLTOWN, NJ

Nestled in the heart of Middlesex County between East Brunswick and North Brunswick is “the greatest little town in all the land.” The Borough of Milltown, a 1.6 mile tract with about 7,000 residents, is in a word, America. From our vibrant Main Street shops, churches and homes to our fine schools, parks and pools, Milltown is an ideal environment to raise a family and enjoy a tight knit community where everyone is thought of as your neighbor. Since 1896, Milltown has been a special place to live, work and play.

Milltown is governed under the Borough form of government by a Mayor and a six member Borough Council. The Mayor is directly elected by the voters to serve a four year term of office. Members of the Borough Council serve three year terms on a staggered basis, with two seats up for election each year. Milltown is in the twelfth congressional district and is part of New Jersey’s seventeenth legislative district.

Students enrolled in public school for Kindergarten through third grade attend Parkview Elementary School.

Students enrolled in public school grades four through eight attend Joyce Kilmer Middle School. Students in public school grades nine through twelve attend Spotswood High School in Spotswood as part of a sending/receiving relationship with the Spotswood Board of Education.
